

**Survivor 50 Challenge**  
**Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY TO PARTICIPATE OR WIN.**

**MUST BE AT LEAST 18 YEARS OF AGE AND THE AGE OF MAJORITY (19 IN ALABAMA AND NEBRASKA; 18 IN ALL OTHER STATES) TO PARTICIPATE. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

**THESE OFFICIAL RULES CONTAIN A CLASS ACTION WAIVER AND AN ARBITRATION PROVISION (SECTIONS 7 & 10). IF YOU DO NOT AGREE TO BE BOUND BY THESE RULES, YOU MAY NOT PARTICIPATE IN THE CHALLENGE.**

The following promotion is intended for participants in the fifty (50) United States and District of Columbia. The Challenge shall be construed and evaluated according to the laws of the United States. Further eligibility restrictions are contained in the Official Rules below.

**1. DESCRIPTION/HOW IT WORKS:** The “Survivor 50” Challenge (the “**Promotion**”) will consist of fifty (50) separate challenges (each a “**Physical Challenge**”) to take place at a specified physical location throughout the U.S. (each a “**Location**”) and one (1) virtual challenge to be conducted on the internet (“**Virtual Challenge**” which together with the Physical Challenges may be collectively referred to as the “**Challenge(s)**”). The Promotion will begin on January 31, 2026 at 12:00:01 a.m. Eastern Time (“**ET**”) and end at the conclusion of the last Participation Period (as defined below), but in no event later than February 25, 2026 at 11:59:59 p.m. ET (the “**Challenge Period**”). Each Physical Challenge will have its own distinct start and end date and time (each a “**Challenge Participation Period**”), which will start when the first clue related to the corresponding Physical Challenge is revealed and end at the time stated in those same clues. The Virtual Challenge will start and end concurrently with the Challenge Period. Specific dates and times for each Physical Challenge will be communicated to registered individuals and will be displayed on [www.survivor50challenge.com](http://www.survivor50challenge.com) (“**Challenge Website**”) at least three (3) days’ prior to the start of each Challenge Participation Period. During each Challenge Participation Period (and throughout the Challenge Period for the Virtual Challenge), clues will be posted on the Challenge Website to allow Participants to determine the hiding spot for the immunity idol (“**Immunity Idol**”) in each corresponding Location (in the case of the Virtual Challenge, the corresponding Immunity Idol will be hidden online). Each eligible Participant who (i) locates an Immunity Idol and (ii) registers their discovery in accordance with these Official Rules) during the applicable Challenge Participation Period will be entered into a random drawing for the corresponding Challenge for a chance to win a Prize (as defined herein). The dates of the Challenge Participation Period for each corresponding Challenge will be posted on the Challenge Website. You must be registered in order to access the Participation Periods for each Challenge.

The sponsor of this Challenge is CBS Interactive Inc., 1515 Broadway, New York, NY 10010 (“**Sponsor**”).

**Sponsor reserves the right to change a Challenge Participation Period, Location, and all other dates or times in connection with this Challenge, at any time and in its sole discretion. Any changes will be posted at the Location, as well as on the Challenge Website. Participants are encouraged to visit the Challenge Website frequently for information regarding the Challenge Participation Periods, Locations, and Dates for each Physical Challenge.**

**2. ELIGIBILITY:** Only open to legal United States residents residing in the fifty (50) United States and Washington, D.C., (each, a “**Participant**”, collectively the “**Participants**”). Eligible Participants must be at least eighteen (18) years of age and the age of majority or above in their state of primary residence (nineteen (19) in Alabama and Nebraska, and eighteen (18) in all other states) at the time of

participation in a Challenge. Employees, owners, shareholders, officers and directors of Sponsor and Creative Zing Promotion Group, Tool of North America, LLC, CBS Broadcasting Inc., CBS Survivor Productions, Inc. Survivor Productions, LLC, DJB Holdco, LLC, Paramount Global, SEG Holdco LLC, Metro-Goldwyn-Mayer Television, and Metro-Goldwyn-Mayer Studios Inc., (collectively, the "**Challenge Entities**") and each of their respective parent companies, affiliates, divisions, subsidiaries, agents, representatives, promotion and advertising agencies and the immediate family members, and/or household members of each, are ineligible to participate in the Promotion. For purposes of the Challenge, "**Household Members**" shall mean those people who share the same residence ("**Household**") at least three months a year, whether or not related; "**Immediate Family Members**" shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses, regardless of where they live. Sponsor reserves the right to disqualify any Participant at any time in its sole discretion.

**3. HOW TO PARTICIPATE:** To participate in any Challenge, Participants must first go to the Challenge Website and follow the on-screen instructions to register for the Promotion. Participants must provide the following information upon registration: Name, Email Address, complete mailing address including zip code, Date of Birth, and Phone Number. Participants may also provide Social Handles (optional). **Participants must register separately for each Physical Challenge and/or the Virtual Challenge in order to participate and/or view the applicable clues.**

(a) **For the Physical Challenges:** At the start of the Challenge Period, Sponsor will post clues on the Challenge Website that will help Participants to locate the Immunity Idol for one or more Physical Challenges, which will be physically hidden somewhere in the applicable Challenge Location. Sponsor will continue to post clues for each of the remaining fifty (50) Physical Challenges on the Challenge Website throughout the Challenge Period. Once a Participant finds the Immunity Idol at a Challenge Location ("**Hiding Spot**"), the Participant must follow the instructions provided at the Hiding Spot to (i) register that they have found the Immunity Idol, (ii) take a photo with the Immunity Idol, and (iii) submit their photo as directed. Upon successful completion of the above steps, an eligible Participant will receive one (1) entry ("**Entry**") into the random drawing ("**Drawing**") corresponding to that Physical Challenge. Representatives of Sponsor will be present at each Physical Challenge's Hiding Spot to assist Participants in taking their photos and completing registration of their Entries. Participants must follow all posted instructions of Sponsor's representatives at Hiding Spots. Failure to comply may result in disqualification from the Challenge in Sponsor's sole discretion. **LIMIT ONE (1) ENTRY/PER PERSON/PER EMAIL ADDRESS/PER PHYSICAL CHALLENGE.**

In the event a Physical Challenge at a specific Location must be cancelled for any reason after it has been announced, registration for that Location will immediately stop. Then, an email will be sent to all Participants who have registered for that Location prior to the cancellation informing Participants that it has been cancelled. The email will contain a link to a registration form. Participants will have twenty-four (24) hours from the time the email is sent to follow the instructions in the email to register and receive one (1) Entry into the Drawing corresponding to that Location ("**Contingency Entry**"). To be eligible for a Contingency Entry, entrants must a) have been registered for the corresponding Location prior to the announced cancellation date; b) not have changed their Location selection to the cancelled Location after the announced cancellation date; and c) changed their Location selection from the cancelled Location to another Location prior to the announced cancellation date.

(b) **For the Virtual Challenge:** To participate in the Virtual Challenge, go to the Challenge Website and locate "Base Camp" registration. Complete the Virtual Challenge registration form in its entirety and follow the instructions to answer three (3) multiple choice questions. You must answer all three (3) multiple choice questions correctly to receive one (1) Entry into the Drawing for the Virtual Challenge. **LIMIT ONE (1) ENTRY/PER PERSON/PER EMAIL ADDRESS FOR THE VIRTUAL CHALLENGE.**

All Entries must be received by the end of each applicable Challenge Participation Period, (or the end of the Challenge Period for the Virtual Challenge) in order to qualify.

No automated entry devices and/or programs permitted. Multiple Participants are not permitted to share the same email address. Any attempt by any Participant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations and logins, or any other methods may void all of that Participant's Entries and result in disqualification of that Participant, at Sponsor's discretion. Receipt of Entries will not be acknowledged. ELIGIBLE PARTICIPANTS MUST ENTER IN ACCORDANCE WITH THESE OFFICIAL RULES. NO OTHER METHOD OF ENTRY WILL BE ACCEPTED. Participation in the Challenge constitutes Participant's understanding of, full and unconditional agreement to, and acceptance of these Official Rules. Sponsor reserves the right to disqualify any Participant that Sponsor determines in its sole discretion to be in violation of any term contained in these Official Rules. Sponsor's decision not to enforce a specific provision of these Official Rules does not constitute a waiver of that provision or of the Official Rules generally.

**4. WINNER SELECTION AND NOTIFICATION:** At the conclusion of the Challenge Period, fifty-one (51) potential prize winners (each, a "**Potential Winner**" and collectively, "**Potential Winners**") will be selected via random Drawings conducted by Sponsor or its designee from all eligible Entries received during the applicable Challenge Participation Period. There will be fifty-one (51) separate Drawings – one for each of the fifty (50) Physical Challenges and one (1) for the Virtual Challenge. Potential Winners will be notified via email and/or telephone to the email address or phone number provided on the registration form by a representative of Sponsor. Potential Winners will be required to respond (as directed) to the notification within forty-eight (48) hours (or a shorter time if required by exigencies) of attempted notification. The failure to respond within the stated time period may result in forfeiture of the prize. Potential Winners will then be emailed, to the email address provided, and required to verify age and address, sign under penalty of perjury, and return within seventy-two (72) hours of attempted email notification an affidavit of eligibility, a liability release, and, unless prohibited by law, a publicity release and other legal documents as may be required by Sponsor in its sole discretion (collectively, the "**Prize Claim Documents**"). Failure to respond to the notification and/or return the Prize Claim Documents within the specified time may result in forfeiture of the prize and selection of an alternate Potential Winner from the remaining eligible Entries for that Challenge, time permitting. A prize will not be awarded/fulfilled until all such properly executed Prize Claim Documents are returned. If a Potential Winner cannot be notified, is found to be ineligible, is unable to accept the prize, or if a Potential Winner is disqualified for any reason, the prize will be forfeited, and Sponsor reserves the right to conduct up to two (2) alternate Drawings for each applicable Challenge in accordance with the above procedure, after which the prize in question may go unawarded. Sponsor reserves the right to disqualify anyone not fully complying with the Official Rules or anyone that appears on any restricted list for any of the Challenge Entities, as determined in its sole discretion.

ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CHALLENGE. AN ENTRANT IS NOT A WINNER OF ANY PRIZE UNLESS AND UNTIL ENTRANT'S ELIGIBILITY HAS BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE. Upon verification of eligibility, each Potential Winner shall be deemed a "**Winner**."

**5. ODDS OF WINNING:** Odds of winning depend on the total number of eligible Entries received for the applicable Physical or Virtual Challenge.

**6. PRIZES:** Fifty-One (51) prizes (each, a "**Prize**") are available to be awarded in the Promotion (one (1) prize per each Physical Challenge and one (1) prize for the Virtual Challenge). Each Prize consists of one (1) 3-day/2-night trip ("**Trip**") for the Winner and one (1) travel companion ("**Guest**") to Los Angeles, CA. The Trip will consist of the following: a) (if Winner resides more than 200 miles from Los Angeles), round-trip economy class air transportation for the Winner and their Guest from a major airport near the Winner's home to Los Angeles, CA (departure and arrival airports will be selected at the sole discretion of Sponsor); b) hotel accommodations for two (2) nights, in a hotel as chosen by the Sponsor (one (1) room, double occupancy, room and tax only) in Los Angeles, CA; and c) admission for Winner and

Guest to special Survivor event. Approximate Retail Value ("ARV") of each Prize: Five Thousand Dollars (\$5,000). ARV of all Prizes to be awarded in the Promotion is: \$255,000. Actual retail value of Prize may vary based on Winner's departure point, date of booking, any airfare fluctuations, and seasonal pricing; any difference between the actual retail value and the ARV will not be awarded.

**TRAVEL IS CURRENTLY SCHEDULED FOR MAY 19 THROUGH MAY 21, 2026. WINNER AND GUEST MUST BE AVAILABLE TO TRAVEL ON THESE DATES OR WILL BE INELIGIBLE TO RECEIVE THE PRIZE.**

The dates of departure and return are subject to change, at Sponsor's sole discretion. All Prize details are at the sole discretion of the Sponsor. If the Winner is unable to participate in the Trip during the dates chosen by Sponsor, the Prize will be forfeited in its entirety and, time permitting, an alternate Winner may be selected. **Ground transportation to/from airport and hotel is NOT included.** In the event that the Trip, or any portion of the Trip, listed in the Prize description does not or cannot take place as scheduled or at all, for reasons including but not limited to scheduling conflicts, cancellations, postponement, or for any other reason, then assuming the Winner is willing and able to travel on the dates chosen by Sponsor, the Winner will receive the remaining components of the prize, which shall constitute full satisfaction of Sponsor's Prize obligation to the Winner, and no other or additional compensation will be awarded. Sponsor will not replace any lost or stolen Prizes, or components thereof. Sponsor makes no representations or warranties with respect to any Prize. Winner is solely responsible for any and all unspecified expenses in conjunction with acceptance and use of the Prize, including but not limited to parking, meals, souvenirs, concessions and any other expenses not specifically mentioned as being included. Prize must be accepted as awarded.

All bookings (flight and hotel) are subject to availability, changes in itinerary and other restrictions. Blackout dates may apply. Prize Trip must be booked through Sponsor designee. Winner and Guest must travel together on same itinerary for the Trip. Guest must be at least thirteen (13) years of age or older at the time of travel, and if a Guest is less than the age of majority in their state of residence, the Winner must be such Guest's parent or legal guardian. If Winner is between the ages of eighteen (18) and twenty-one (21), they must be accompanied by an adult of at least twenty-one (21) years of age in order to check into the on-site hotel. The Guest must complete applicable Prize Claim Documents prior to ticketing of the Prize. In the event the Guest is a minor, the applicable Prize Claim Documents must also be signed by such Guest's parent/legal guardian on such Guest's behalf. Airline for Prize Trip to be selected by Challenge Entities in their sole discretion. Airline carrier's regulations and conditions apply. Once Trip dates have been booked, no changes, extensions or substitutions are permitted, except at the Sponsor's sole discretion. ALL FEDERAL, STATE AND LOCAL TAXES, AND ANY OTHER COSTS AND EXPENSES, ASSOCIATED WITH THE RECEIPT OR USE OF THE PRIZE ARE THE SOLE RESPONSIBILITY OF THE WINNER. The ARV for Prizes is an estimate made before the Challenge begins. If the actual value of the Prize is less than the ARV stated herein, the Winner will NOT be entitled to a check, cash or other form of payment for the price difference. The round-trip air transportation element for any Trip Prize begins and ends at

the point of departure. Other hotel fees are not included and if applicable may be payable at the time of check-out by the Winner. Any hotel cancellations or changes to hotel reservations after confirmation must be made with the Sponsor directly, and the Winner is solely responsible for any charges and/or fees arising from hotel changes. Winner cannot assign or transfer the Prize to another person, except at discretion of Sponsor. If the Prize cannot be awarded due to circumstances beyond the control of Sponsor, a substitute prize of equal or greater ARV will be awarded. Other restrictions may apply. The Prize, and all portions of the Prize, are awarded AS IS, WITHOUT WARRANTY OF ANY KIND, express or implied, without limitation.

In connection with the Trip, please be advised that airport, airline and hotel policies, CDC guidelines, and the recommendations of health officials must be followed. In addition, Winner and Guest should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before visiting any destination. Please note that any public location where people are present provides an inherent risk of exposure to COVID-19, and Sponsor cannot guarantee that any person will not be exposed during the Trip. By accepting the Prize, Winner and Guest, expressly assume the risk that during the Trip they may be exposed to COVID-19, the Coronavirus that causes COVID-19, or other communicable and/or infectious diseases. Winner and Guest, if any, expressly understand that these risks include contracting COVID-19 or other communicable and/or infectious diseases and the associated dangers, medical complications and physical and mental injuries, both foreseen and unforeseen, that may result from contracting COVID-19 or other communicable and/or infectious diseases.

**Trip Conduct:** Winner and Guest shall conduct themselves with due regard to the public conventions and morals. The Winner and Guest shall not, while representing the Challenge Entities during the Trip and/or any of the events, or any portion thereof, listed in the Prize description, commit an offense involving moral turpitude under local laws or ordinances. The Released Parties shall not be liable for: (i) any injuries, losses, liabilities or damages of any kind including personal injury or death caused by the Prize or resulting from acceptance, possession or use of a Prize including participation in

any activity related thereto, or from participation in the Promotion or any Challenge; (ii) telephone system, telephone or computer hardware, software or other technical or computer malfunctions, lost connections, disconnections, delays or transmission errors; (iii) data corruption, theft, destruction, unauthorized access to or alteration of entry or other materials; (iv) late, lost, delayed, stolen, misdirected, postage-due, incomplete, unreadable, inaccurate, garbled or unintelligible entries, communications or affidavits, regardless of the method of transmission; (v) any inability of Winner to accept or use a Prize (or portion thereof) for any reason and such Prize or portion thereof shall be forfeited; or (vi) any printing, typographical, human administrative or technological errors in any materials or activities associated with the Promotion or any Challenge. BY PARTICIPATING IN THE CHALLENGE, PARTICIPANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (1) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE CHALLENGE, OR ANY AWARD AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (2) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED, (IF ANY), NOT TO EXCEED TWO HUNDRED FIFTY DOLLARS (\$250.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; AND 3) UNDER NO CIRCUMSTANCES WILL ANY PARTICIPANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND PARTICIPANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS, AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU. WITHOUT LIMITING THE FOREGOING, THIS CHALLENGE AND ALL PRIZES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT.
